

Juugo Europe Ltd. Privacy Policy

1. Personal information

Juugo Europe Ltd. is sensitive to privacy issues and treats very seriously the ongoing trust our Independent Distributors have placed in us. You can relax knowing that Juugo Europe Ltd. aspires to best practice procedures and are constantly in the process of ensuring the security and protection of your private information.

Juugo Europe Ltd. only collects personal information when you choose to provide it voluntarily. Typically, this is when you use or register with the site. Such "personal information" Includes data that can identify you as a specific individual, such as your name or email address; and, IP address. While you can browse much of our site without registering, you still need to register in order to take advantage of certain features and offers.

2. Retaining this personal information helps us to:

- Provide you with better customer service
- Ensure you accumulate any rewards owing
- Present the web site according to your preferences
- Provide Independent Distributor services generally and to facilitate provision of member services outsourced to other parties such as financial services providers.
- Communicate special offers and featured items, if you choose to receive such notices
- Respond to your questions or suggestions

Please note that whenever you submit any information to us in connection with any transactional or Independent Distributor services, you consent to the processing of this information by Juugo Europe Ltd. or our agreed business partners as necessary, to provide the services in which you are participating.

3. Access by third parties

In order to ensure the security and protection of your personal information, Juugo Europe Ltd. does not generally allow third parties to access your personal information. However, there are some exceptions that apply in respect of:

- our agents, contractors, or other third party service providers that we have engaged to assist us in providing you with Juugo Europe Ltd. products and services;
- Relevant regulators and authorities where the law requires or permits us to do so; or banks and financial services providers in order to

facilitate provision of their banking or financial services to our Independent Distributors.

The personal information we disclose in these circumstances will be limited to your identity particulars (Including proof of identity), the fact that you are a Independent Juugo Distributor and the details of that Independent Distributor, as well as any other details which are reasonably requested of Juugo Europe Ltd. Juugo Europe Ltd. does not share personal information with direct marketing or similar organizations, as we consider that this property is commercial in confidence for the use of Juugo Europe Ltd. alone.

4. Browsing and the use of Cookies

Juugo Europe Ltd. uses cookie technology as part of our web site's tracking method. A cookie is a small piece of information sent by a website that is saved on your hard disk by your computer's browser. We only use cookies when a user navigates certain parts of the Juugo Europe Ltd. website, such as during the signup process when we keep track of which page the user is currently viewing. We do not use cookies to track any other information including personal and private details of the user.

We also use standard web server log files to help us count visitors and evaluate our site's technical capacity. We use this information to find out how many people visit Juugo Europe Ltd. help us arrange the pages in the most user-friendly way, keep the site browser-friendly, and to make our pages more useful to our visitors. We record information on site traffic but not store information on individual visitors to our site, so no information about you in particular will be kept or used.

To browse without cookies, you can configure your browser to reject all cookies, or to notify you when a cookie is set. (Each browser is different, so check the "Help" menu of your browser to learn how to change your cookie preferences.)

5. How we protect the security and quality of your personal information

The security of your personal information is very important to us and we are committed to protecting the information we collect. Juugo Europe Ltd. uses firewalls and 128-bit encryption on transactions. We also have security measures in place at our physical facilities to protect against the loss, misuse, or alteration of information that we have collected from you at our web site.

6. Juugo Europe Ltd. will take all reasonable steps to:

- Make sure that the personal information we collect, use or disclose is accurate, complete and up to date;
- Protect the information from misuse, loss or unauthorized access, modification or disclosure both physically and through computer security methods; and
- Destroy or permanently de-identify the information if it is no longer needed for any purpose.

7. Our policy regarding sharing of information

Our policy is straightforward: we never sell or rent your personal information to any third parties under any circumstances unless required to fulfill an electronic transaction

8. Email, Mailing Lists, and Other Services

When you send us an email, we use your email address to thank you for your comment and/or reply to your question. Usually, we will store your communication and our reply in case we require it for future reference. Beyond our initial reply, we will never use your email address to send you any unsolicited message or information, nor will we share it with or sell it to anyone else for such use. We will not use your address or other information to provide you with any unsolicited message or information (unless it is required in order to keep you informed of your benefits as a Independent Juugo Distributor), nor will we share it with or sell, rent or lease it to any third party for such use.

9. How you can decide what communication you'll receive from us:

If you choose to receive them, Juugo Europe Ltd. may periodically send you email messages or SMS messages describing updates, new features, or promotional offers related to this web site. You can choose to stop receiving these messages at any time. Simply follow the instructions posted in your member site.

If you do not explicitly choose to receive informational emails, the only email messages you will receive from Juugo Europe Ltd. will be to respond to email inquiries that you send us.
